Principal symptoms of silicosis are coughing and breathlessness. Some individuals may exhibit an allergic response upon exposure to this product, possibly due to the trace amounts of chromium present. Crystalline silica and hexavalent chromium compounds are classified as carcinogenic to humans (IARC Group 1).
